

2026 CRISPIM BJJ & MMA KIDS IN-HOUSE BJJ TOURNAMENT #3 of 4

- Saturday, September 12, 2026 at the Pleasanton Academy (6668 Owens Drive, Suite 100)
- The weigh ins and tournament will start at 8am sharp.
- Weigh ins – it is extremely important that you weigh your children prior to completing the registration forms. In the past, we have had kids who weighed 10-20lbs off which makes the matches unfair. If your child is more than 5 lbs off from what you wrote on the registration form, we will try to change their matches, but if we are not able to, they may not be able to compete.
- Tournament is expected to end between 11am and 12pm.
- Kids ages 4-15 (white to green belts)
- Special Tournament Series – the kids will earn points at each of the tournaments/matches they participate in. This is the 3rd tournament (out of 4) of the 2026 Kids In House Tournament series. Here are the points:
 - 1st Place – 5 points
 - 2nd Place – 3 points
 - 3rd Place – 1 point
 - For each match won at the tournament – 3 points
 - Each tournament participated in – 10 points
 - Participate in all 4 tournaments – 20 points
 - Points earned in a match:
 - If a child scores 10 points or less – earn 3 points
 - If a child scores 11 points or more – earn 4 points
 - If a child submits opponent – earns 5 points
 - Can receive both points for scoring and for submission in the same match.

At the end of the 4 tournaments, we will total the points and the winners will receive:

1st Place – Xbox or Playstation or IPAD (up to \$500 value)

2nd Place - \$250 Amazon gift card

3rd Place - \$100 Amazon gift card

REGISTRATION FORM:

And all documents and payments need to be in by 08/29/26 or your child will not be able to compete.

TYPE OF TOURNAMENT:

The Crispim BJJ & MMA Kids In-House Tournament 2026 will use a DOUBLE ELIMINATION SYSTEM for the kids.

PRIZES:

All athletes in 1st, 2nd and 3rd place will be awarded gold, silver and bronze medals respectively.

WEIGH-INS:

All weigh-ins will be WITH THE GI ON. All competitors must be at the academy by 8:00am. All competitors must wear a CLEAN and a SOLID colored Brazilian Jiu-Jitsu GI (Kimono). No mixing of colors. Example- white pants and blue top or blue pants and white top, etc. will not be allowed.

SCORING SYSTEM:

In order to receive the points, the competitor must have control of their opponent for 3 seconds. Once the athlete has the opponent controlled the athlete will receive points.

- THROWS AND TAKEDOWNS ----- 2 points
- KNEE ON THE STOMACH ----- 2 points
- SWEEP & REVERSE FROM THE GUARD ---2 points
- PASSING THE GUARD -----3 points
- FRONT MOUNT POSITION -----4 points
- BACK MOUNT POSITION -----4 points
- TAP-OUT – END OF MATCH. The competitor is declared the immediate winner.

*ADVANTAGE POINTS ARE NOT AWARDED AT THIS COMPETITION

** SUDDEN DEATH applies if score is tied at the end of match (see below for Sudden Death definition).

MATCH LENGTH:

3 minutes each

SUDDEN DEATH:

Overtime is 1 minutes During the Sudden Death overtime, the fighter to score the FIRST POINT of any type is declared the immediate winner and the match is over. If no score is made by either fighter during the Sudden Death Overtime, then the referee will determine and declare the winner of the match.

COACHING CORNER:

There will be Crispim BJJ/Wild Boyz MMA coaches at the tournament coaching the children. We respectfully ask that all family/friends refrain from coaching their children. One of the reasons for the In-House tournament is to help teach coach-ability to the children and how to listen to their coaches' voices while competing. If a child is hearing too many people coaching them, they will get confused and have to choose who to listen to. So please help us provide a positive competitive environment for all of the children. And cheering and encouraging is welcome!

RULES:

LEGAL TECHNIQUES:

Any techniques not mentioned in the ILLEGAL TECHNIQUES section are allowed in competition.

Waiver Release, Indemnification, and Hold Harmless Agreement

Please read this form carefully and be aware that in signing up and participating in this in house tournament, you will be waiving and releasing all claims for injuries arising out of this competition on behalf of yourself and/or your child in which you have legal guardianship.

You hereby waive and release all claims for injuries arising out of this competition, including negligence claims, that you or the named participant might sustain. The terms "I", "me", "you," and "my" refer to the participant and also refer to the participant's parents, guardians, heirs and all other family members.

In registering for this competition or tournament you hereby agree as follows: As a participant in this competition or tournament, and any and all activities associated with such competition or tournament, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, damage, or loss which I may sustain as a result of participating in any manner in any and all activities connected with or associated with such activities and involve substantial risks of injury. I agree to waive and relinquish any and all claims I or my child (in which I have legal guardianship) may have as a result of participating in this tournament or competition (and all other associated activities) against any and all persons participating in this tournament or competition. I also hereby fully release and discharge Crispim BJJ Barra Brothers LLC and its members and Wild Boyz MMA LLC and its members or any other person or entity who organized or operated this tournament or competition (or any activities associated with this tournament or competition), the owner and/or operators of the premises in which this tournament, competition or other associated activities are held, all predecessors, successors, subsidiaries, and parent companies of all such entities, all affiliates and related companies of all such entities, all owners, officers, members, employees, and agents of all such entities, all vendors, contractors and subcontractors hired by such entities, and all related parties and persons of such entities (collectively the "Released Parties") from any and all claims which I may have or which may accrue to me on account of, or relating in any way to, my participation in this tournament or competition (and any associated activities with this tournament or competition) regardless of the cause of action, including, but not limited to, negligence claims and regardless of whether such claims relate to alleged acts or omissions of any of the Released Parties. I acknowledge and recognize that the released Parties have the exclusive right to defend any such claim covered under this Agreement using counsel of their choosing with such costs and expenses to be reimbursed by me in full. I acknowledge that any decision by any of the Released Parties to use counsel of their own choosing in defending against any claims covered by this Agreement does not in any way negate or affect any of my other obligations under this Agreement, including my obligations to indemnify, release, or hold the Released Parties harmless from such claims. I further understand and agree that the terms such as "participation" and "activities" referred to in this Agreement include, but are not limited to, the provision of or failure to provide proper instruction or supervision in the usage and adjustment of any and all machinery, equipment, and apparatus, and anything related to my use of the services, facilities, or premises involved in this tournament.
